	itle 22 ec. 4.13	Prior to approval by the Joint Operating Committee, the Strategic Plan, and any revisions, shall be made available for public inspection in the school's administrative offices and the public library until the next regular Joint Operating Committee meeting.
S	C 1850.1	The Joint Operating Committee may periodically conduct surveys to determine the vocational technical needs of the participating school district in order to facilitate comprehensive planning.
