### 8. PERSONNEL MATTERS

### A. HIRE HVAC INSTRUCTOR

It is recommended approval be granted to hire Travis Weaver, Beavertown, PA, as the SUN Area Technical Institute HVAC & Plumbing Technology Instructor, effective August 10, 2022. Mr. Weaver will be hired in accordance with the Collective Bargaining Agreement and his credentials as of his first workday, with a step placement no higher than Step 3. Mr. Weaver will be compensated at his per diem daily rate for an additional 10 workdays in July/August 2022. Fringe benefits will be in accordance with the Collective Bargaining Agreement and include 10 sick leave days, three personal leave days, and health and life insurance coverage. Mr. Weaver will need to fulfill the obligation of acquiring his vocational certification with PDE.

## **B. HIRE HEALTH PROFESSIONS INSTRUCTOR**

## 9. PROGRAMS

#### A. LUNCH PROGRAM/CAFETERIA POLICIES 2022-23 SY

It is recommended approval be granted to operate the SUN Tech Cafeteria for the 2022-23 SY under the following guidelines:

- SUN Tech will screen eligible students to Federal Guidelines to determine eligibility for the free and reduced lunch program.
- Set the price for one half pint of milk at \$.50 for students and adults.
- Set the price for the Type A lunch or fast-food platter at \$3.00 for students and \$3.75 for adults.
- Grant permission to the Director of Food Services to establish a 'la carte prices.
- Set the workday for one part time cafeteria employee at four hours and one at five hours per day maximum.
- Set the workday for the Head Cook at six and one-half hours per day, up to a maximum of 186 days per year.

## B. CONSULTING PHYSICIAN, 22-23 SY

It is recommended the approval be granted to appoint The Family Practice Center, P.C., as Medical Consultants, including the Cosmetology program, for the 2022-23 SY; no fee will be charged for this service.

## A. DEPOSITORIES, 2022-23 FY

## B. INVESTMENT ACCOUNT APPROVAL

It is recommended approval be granted to approve the creation of an investment account with FNB Wealth Management to invest reserve cash in PA Act 10 approved investments. Investments will primarily be into Treasury Bills and FDIC insured CDs that will increase rate of return while maintaining principal preservation. FNB Wealth Management has extensive experience in constructing investment portfolios and will customize the investments to match the needs of SUN Area Technical institute. Initial investment amount of \$1,500,000 is recommended.

## C. ACCOUNT BALANCE TRANSFER

It is recommended approval be granted to transfer the remaining funds from the Capital Project Account with PSDLAF to the Investment Account with First National Bank. These funds will be designated to be used for the West Campus Electrical Systems and Mechatronics Student Workspace Project.

## D. SOLICITOR, 2022-23 SY

It is recommended approval be granted to retain Patrick Fanelli, Fanelli Willett Law Firm, as Solicitor for the 2022-23 SY, effective July 1, 2022, at the following rates:

- Attorney time for professional services, special and regular board meetings; \$135 per hour; no mileage charges; travel time is charged.
- \$165 per hour for specialized matters, such labor law, special education, and litigation.
